UHKF (University Hospitals Kingston Foundation) will provide business receipts upon request for qualifying gifts contributed in support of events subject to the following Canada Revenue Agency (CRA) guidelines.

- Qualifying items of merchandise require a verifiable Fair Market Value (FMV) and gifts in excess of \$1,000.00 may require an evaluation by an independent appraiser.
- Items drawn from inventory (or gift certificates for those items) should be considered promotional business expenses to maximize available tax benefits and therefore a charitable gift receipt will not be issued.
- A charitable gift receipt cannot be issued for a gift, which has been made in exchange for a material benefit, such as promotion or advertising.
- The CRA states: "A gift in kind does not include a gift of service." A charitable gift receipt cannot be issued for contributions of time or services. We would be pleased to acknowledge such gifts with a thank you letter. Donors of gifts donated for sale at charity events are eligible for a charitable receipt based on the lesser of the actual price paid at the sale or FMV. Purchasers of items at a charity event may be eligible for a charitable receipt based on the difference between the actual price paid and the FMV, if in compliance with CRA guidelines.
